RESOLUTION

ON MOTION BY COMMISSIONER VIHLEN, SECONDED BY COMMISSIONER YARBOROUGH, THE FOLLOWING RESOLUTION WAS UNANIMOUSLY ADOPTED AT A REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, ON THE 14TH DAY OF DECEMBER, 1971.

WHEREAS, the Board of county commissioners of Seminole County, Florida having been petitioned by certain of the citisenry residing with an area, the legal description of which is set forth below:

All that land included from a point 800 feet due west of the southeast corner of Section 19, TWP 21S, Range 32E, due north to 400 feet north of State Road 419, thence due east to the section line bounding section 20, thence due north along the section line to a point 1320 feet south of the North West corner of Section 20, thence due East for 1320' thence due north to Willingham Road thence due East to the Railroad Right of Way, old State Road 13, thence southerly along the Railroad Right of Way to a point approximately 2640 feet south of the northern border of Section 20, thence westerly to Willingham Road, thence south to the Southern boundary line of Section 20, thence Westerly to the P.O. B.,

and.

WHEREAS, the Board of County Commissioners finds that said area is not within an area either chartered by law or named by custom, and

WHEREAS, the Board of County Commissioners finds that it would not be against the interest of the citizens of Seminole County to allow this area to be henceforth known as the Village of Taintsville but rather would promote, foster and encourage local interest and pride, and would otherwise serve all the citizens, and

WHEREAS, the Board of County Commissioners of Seminole County has received no objection to such designation of this area,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Seminole County:

- 1. That the designated area henceforth be known as the village of Taintsville, without charter or power in law and further to be known by such name only so long as custom and habit allow.
- 2. That a copy of the Petition of the citizens involved be attached hereto and by reference incorporated herein.
- 3. That this Resolution shall take effect immediately upon its passage and adoption.

The County Attorney advised that he has drawn a proposed resolution with regard to the petition from residents requesting that their area be known as Taintsville for the Board's consideration.

Motion by Commissioner Vihlen, seconded by Commissioner Kimbrough and carried, setting December 14,1971, for an agenda item to consider the adoption of a resolution acknowledging that an area as delineated on petition received and filled on November 2, 1971, be henceforth known as Taintsville, and that property owners within said area be notified by the Zoning Department of the date and subject to be considered.

PROPOSED DESIGNATION OF TAINTSVILLE-December 14, 1971-page 100

The Chairman annouced that the Board previously received a petition from property owners living in an area located between Chuluota and Oviedo on SR419 requesting that their area be known as the village of Taintsville. He stated the Board set this date for consideration of the request and those persons living in this approximate 660 acre area were notified by the Zoning Department that the request would be considered. He stated that most unincorporated areas that do have name designation are those that have a post office or a railroad station designation: He stated it would appear that this is the first request presented to the Board for an area to be designated by name that has no post office or railroad station designation.

The Zoning Director exhibited a map outlining the area petitioned for name designation.

The Chairman read the proposed resolution in full for the Board's consideration.

Mr. Ted Peterson, representing the petitioners, addressed the Board to state that there is a group of property owners in the area that have been meeting for approximately three years and it is their desire to have a name designation to refer to their area the same as Snow Hill and other areas. He stated the name of Taintsville was suggested by Mr. Best. He stated their request was made in all seriousness and they feel the quaintness of the name will be an asset and will draw interest.

Mrs. Leslie Gross addressed the Board stating this area has been called Taintsville for some ten or fifteen years by the residents.

The Zoning Director advised that there are not more than 30 property owners in the entire area proposed to be named.

Mr. Peterson stated that every property owner he has talked with is in agreement with the proposed name.

Mrs. Lenel Perry addressed the Board stating she would like information on how difficult it would be to change the name at a later date and the Chairman advised that a change would involve another resolution.

No other person spoke in favor or in opposition.

Motion by Commissioner Vihlen, seconded by Commissioner Yarborough and carried, adopting appropriate Resolution, as shown on page 126 (17) relating to request of certain citizens within a defined geographical area of Seminole County requesting the designation of said area as the Village of Taintsville and resolving that the area henceforth be known as the Village of Taintsville, without charter or power in law and further to known by such name only so long as custom and habit will allow.
